Part One: Reading Comprehension(Score: 24/40)Read the selection below about the change in human values and then answer the questionsthat follow.

Human Values

1 The values of simpler societies for thousands of years were based upon a holistic view of life. Community embraced all individuals who knew that life functions as a whole like an organism with interdependent parts that must be **sustained** for life to continue. Now, we have lost this worldview. We discovered that by focusing on one component, we can make <u>it</u> more productive. However, we forget the balance of the whole. It is the danger of reductionism.

2 In earlier societies, the intimate dependence upon domestic animals gave more appreciation of the whole environment and helped society to realize that life is entwined with all the natural resources of the world. Although it is not so self-evident, the world today is still dependent upon natural resources. One cannot take endless quantities of everything without upsetting the balance that will reduce the quality of life. The earth is in dynamic equilibrium.

3 We need to **ponder** the deeper implications of the lost relationship of our civilization with the environment with each other in our communities and with other societies on earth. I believe better understanding of these relationships is a key to our future options. Thinking more about where we have come from will help us to draw up a balance sheet of what we gained, what we are in danger of losing and where we are going.

4 We pay a price. Actually, it will largely be paid by future generations. Today our focus is on profit, the desire to make more money this year than last and the supremacy of capital. All <u>these</u> urge upon the producer the need to succeed as a business person and to neglect the long-standing practices of sustainable production, care of animals and good management of the environment. New scientific techniques now challenge the sustainability of the environment, put the animal in unnatural conditions, direct its hormonal system, and view the animal **solely** as a resource to be exploited for profit and lower prices. Slowly, under pressure and with reluctance, some governments are legislating minimally against the most extreme practices in the interests of animal **welfare** and of the environment. Most politicians resist such legislation because of opposition from businessmen and a society ignorant and uninterested in these issues.

5 A life agenda driven only by values that maximize the material prosperity of the individual is a reductionist view. It takes no account of the larger whole. Yet, the history of human civilization is the story of solidarity in the community slowly built up by hard work and wisdom but periodically destroyed by narrow agendas and foolishness.

6 Civilizations progressed when the quality of human life was defined to include transcendence as well as material prosperity. Civilizations declined when a material agenda and

individual greed squeezed out values. Europe has a heritage which upgraded society over many centuries and defined the quality of life in multiple dimensions. But, to our loss, we are neglecting our heritage and increasingly having a tunnel vision for personal material prosperity.

7 We have lost touch with the values that our ancestors learned from their animals. They knew the fact that for a cow to have a calf and produce milk next year, you cannot take all the resources of the cow this year.

8 Under the influence of science and market economy pressures, values in our world have lost the holistic approach. We are driven by values that are leading us from legitimate self-interest to greed. It is time to give respect to the lessons from animals that guided our ancestors.

9 I am not advocating a return to animal power and primitive lifestyles. The world needs good science and responsible business to create wealth to raise the quality of life throughout our exploding world population. Rather, I am calling for higher human values in our world in the business of making and using the new wealth.

10 We are foolish not to think that wholeness and sustainability are quality of life experiences that are not provided by the search for endless and greater material prosperity. Our current values today are divorced from real and long-term meaning and are unable alone to deliver quality life. We must change - or unpleasant change will be forced upon us and our children. We truly miss the animals and the lessons our ancestors learned from <u>them</u>.
